Next up in the martini glass is the *Hi-Hosey*, which is Boston slang for claiming ownership of something. This particular cocktail is made from a combination of Hendrick's Gin, Chambord, fresh squeezed lime juice and lime cordial.

Perfect for toasting, the bubbly *Poinsettia* is an elegant addition to the cocktail list. The light and flavorful cocktail combines Cointreau, pomegranate mix, Angostura Orange Bitters topped off with Spanish sparkling wine. Finally, for those looking for something to beat the chill, the *Honey Apple Warmer* is a tasty combination of Laird's Applejack Brandy, Barenjager Honey Liqueur, Spice Box Syrup, Angostura Bitters and hot water.
